^{*} Numerous Amendments have been challenged in the courts and all 13 may not appear on the final General Election Ballot. As of Sept. 7th The Florida Supreme Court confirmed Amendment 8 to be stricken from ballot, and confirmed 6, 10 and 13 will appear on.

Position Guide

Amendment 1 (Legislature)

BV: N LWV: O FLC: N FT: O

- Third Homestead Exemption Amendment: Exempting the assessed valuation of homestead property greater than \$100,000 and up to \$125,000 for all levies other than school district levies.

Amendment 2 (Legislature)

BV: S LWV: O FLC: S FT: S

- Limitation on property tax assessments; first put in place in 2008, when the voters passed the non-homestead 10 percent tax cap in. This cap is scheduled to expire on January 1, 2019. This amendment makes that tax cap permanent.

Amendment 3 (Petition)

BV: O LWV: S FLC: S FT: O

- Statewide Voter Approval of Casino Gambling As Only Means To Expand Gambling

Amendment 4 (Petition)

BV: N LWV: S FLC: N FT: S

 Voting Rights Restoration for Felons Initiative for Some Felons; Does not apply to murder or a felony sexual offense.

Florida Amendment 5 (Legislature)

BV: O LWV: S FLC: S FT: O

- Require Two-Thirds Vote of Legislature to Increase Taxes or Fees Amendment

Amendment 6: Rights of Crime Victims; Judges (CRC). BV: N LWV: O FLC: N FT: O

- Marsy's Law; Judicial Retirement Age; and Judicial Interpretation of Laws and Rules Amendment

Amendment 7: First Responder and Military Member Survivor Benefits; Public Colleges and Universities (CRC). BV: N LWV: O FLC: N FT: O

- Extend Benefits to First Responder and Military Member Survivors, Require Supermajority Board Votes for College Fees, and Establishes existing state college system as constitutional entity; provides governance structure

Amendment 9: Prohibits Offshore Oil and Gas Drilling; Prohibits Vaping in Enclosed Indoor Workplaces (CRC) BV: N LWV: S FLC: O FT: S

- Florida Ban Offshore Oil and Gas Drilling and Ban Vaping in Enclosed Indoor Workplaces Amendment

Florida Amendment 10: State and Local Government Structure and Operation (CRC) BV: N LWV: O FLC: O FT: O

Creates the Department of Veteran Affairs and an Office of Domestic Security and Counter-Terrorism within the Florida Department of Law Enforcement, as well as move the legislative session commencement in even numbered years from March to January.

Florida Amendment 11: Property Rights; Removal of Obsolete Provision; Criminal Statutes (CRC) BV: N LWV: N FLC: S FT: S

Florida Repeal Prohibition on Aliens' Property Ownership, Delete Obsolete Provision on High-Speed Rail, and Repeal of Criminal Statutes Effect on Prosecution Amendment

Florida Amendment 12: Lobbying and Abuse of Office by Public Officers (CRC)

BV: N LWV: N FLC: O FT: O

- If the six-year lobbying ban becomes law it would be the strongest revolving door law in the nation. According to the National Conference of State Legislatures, no state currently has more than a two-year ban on former law makers becoming legislative lobbyists.

Florida Amendment 13: Ends Dog Racing (CRC). BV: N LWV: S FLC: O FT: S

Phases out commercial dog racing in connection with wagering by 2020. Other gaming activities
