4. What have you done to prepare yourself to serve in this office?

I served for twenty years (1991 – 2011) on the Rockledge Planning Commission (*past chairman*) before being elected to two *three-year* terms (2011 – 2017) on the Rockledge City Council.

I was elected by the Rockledge City Council members to serve as Deputy Mayor of Rockledge for my last four years. While on the Rockledge City Council, I lobbied County, State and Federal Governments for my constituents. My dedicated service resulted in being honored with the Florida League of Cities "*Home Rule Hero*" award in four consecutive years (2013 – 2017).

I served on the Space Coast Transportation Planning Organization for five years and as vice chairman for the last two. I also served on the regional transportation planning organization. My life has been spent in service to others. It started in high school teaching beginning swimming for the American Red Cross culminating in my current role as a "*Pro Bono*" CPR Instructor for the City of Rockledge and Cocoa Beach instructing

(For Legislative and County Commission races)

1. In the next 10 years, what do you believe will be the top three critical needs of Floridians/ Brevard Country residents? What role will the office you are seeking play in helping meet these needs, and what plans do you have to help us do so?

#1 is developing a trained and qualified workforce. I have had multiple discussions with the EDC on training and retaining a workforce required to meet the demands of business. I see this being started in high school by offering more and more diversified training to high school students leading to certifications, especially for those not intending to attend college. Additionally, a much bolder effort concentrating on post high school Vocational - Technical Training schools.

#2 is the Restoration of the Indian River Lagoon. Introduce and support intelligent legislation on a State level to eliminate the causes of the pollution. The pollution comes from a variety of sources and is not isolated to a local area. This is a time where State oversight is required. The economic value of the IRL (\$7.6 billion) is staggering and every investment in the IRL is an investment in our future.

#3 is “Local Self-Government”. State and Federal Governments serve a vital role in our nation, yet each seems to attempt to dictate what should be local decisions downward to the governing body below. I support local business decisions being made locally. What fits in Miami-Dade County may not fit so well Cocoa Beach or West Melbourne.

2. How do you weigh decisions between the needs of your local district constituency and those of the county/state as a whole?

When elected I will be there to represent my constituency. That being said, there may be times when the bigger picture must also be considered. We, the Cities and Counties, depend on each other and on the State. That will certainly be an opportunity to reach out to the communities for their input.
