




Q2 Roughly how many full-time employees do you currently employ?







Q6 Thinking of your company's overall business revenue....







Q8 Thinking of the impact of regulations, taxes and fess...





Q9 Community Redevelopment Agencies (CRA's) Are Under The Political Microscope.






