- 5. If qualifying by petition, how are you collecting petitions? Through a network of friends, door-door cold calling, and attendance at community events;.
- 6. How many fundraisers have you had? One. However I have over 50 people who have donated to my campaign just through word-of-mouth.

- 9. How many volunteers do you have engaged in your campaign and describe how you are engaging them? 50 through social media and personal contact
- 10. Why are you running for this office? The mission statement for Brevard Public Schools is "to serve every student with excellence as the standard." Since I began teaching in 2004, excellence in my classroom is defined as an "A." Currently, only 40% of schools in Brevard County are "A" schools – with only 50% earning "A" in District 2. With the percentage this low, it is not just a student problem, it is not just a teacher problem, it is not just a school problem – it is a district problem.

I have served in all levels of the school system – elementary, middle, high school, district offices and post-secondary – so I have a firm grasp on some systemic changes needed to set a course to meet our mission.

I recently participated in a forum hosted by the Brevard Federation of Teachers, the Space Coast Association of Realtors, and the Brevard County Firefighters. After qualifying, I will also be looking to some individuals (county constitutional officers and current/former elected officials). I'm available to speak to any group. While we are a non-partisan election, I have reached out to both political parties as my background is broad and my views are mainstream in District 2.

2. The Business community should support my candidacy because:

First, I understand the importance of the role of school board member. I have always believed that the most important government entities are the ones that are closest to the people. School boards, and city/county commissions fall into that category.

I understand that strong schools make for a strong local economy. Schools are a primary factor in who chooses to live in Brevard County. The school board needs to be fiscally responsible through streamlining processes, cutting overhead, improving teacher pay, and maintaining current levels of taxation to make our area as attractive as possible to maintain and enhance our quality of life.

I am for expanded career and technical programs to assist our students who do not go to college. I have worked with the business community for the last six years to obtain internships and job-shadowing opportunities for students.

As well, I have proposed that the district implement a Jack Welsh style differentiation (20-70-10) method in the staffing needs at the district offices. I.E.: the top 20% are groomed for leadership and provided bonuses, the middle 70% are provided a variety of professional development and incentives to grow, and the bottom 10% are placed on probation or let go. This will improve performance drastically.

3. Describe your experience that qualifies you for the position you seek, or to hold public office in general.

First, I have the most wide-ranging school experience of any candidate for school board in any of the districts up for election:

Second, I have the most wide-ranging non-teaching professional experience in Brevard County of any candidate for school board in any of the districts up for election.

- For seven years, I worked in Cocoa Beach in the hospitality/tourism industry networking with local chambers of commerce and other businesses.
- For 10 years, I worked for an aerospace consulting company assisting technical staff in flight and launch safety analyses (including for Space Shuttle and commercial launch vehicles), writing proposals, and attending events.
- For six years, I was the pastor of a church where I managed budgets and personnel. During my tenure, the church grew from 75 to 300 regular attenders.
- I also have worked in social services and served on boards of local non-profits.

Third, I have been an involved parent to three children in Brevard County Schools since 1990. I have been the chair of School Advisory Committees at two different schools and been a member on a third. I have logged hundreds of volunteer hours as a "Just Say No" dad and field trip chaperone. As well, I have coached at the junior varsity (boys basketball) and varsity (boys golf, girls golf, boys tennis) levels.

1. Please describe your experience in financial management, budgeting or oversight that would qualify you to oversee the large budget of the school district/port?

While I do not have in-depth experience in managing a budget as large as BPS, I do have a variety of experience (noted below) in budgeting for organizations. I have begun studying and breaking down the BPS budget into manageable chunks – reviewing each department to compare personnel/overhead ratios and look for areas of potential savings. As well, I have been learning about revenue sources and restrictions.

I love a challenges and solving problems.

I grew up in a rural area of Virginia where teenage drinking was the norm. I then moved to Cocoa Beach in 1980, where drinking by people in my age group was excessive. In 1994, I realized that my consumption of alcohol had gotten out of hand. I didn't know what was causing it, so hit it from all angles. I checked myself into a treatment center for a week, I attended AA for many months, I went back to church, I did outpatient counseling, I changed my diet, I began eating better and exercising some. It is now 24 years later...still clean and sober...no relapses.

In 2015, I realized that I had slowly gotten overweight and out-of-shape. I changed my eating habits and began running. (My son laughs at this as I had always hated running.) Since then, I have lost 50 pounds and have participated in a sprint triathlon, eight 5ks and three half-marathons. My blood pressure recently was 94/62 and my resting pulse at 46.

These stories are just two practical illustrations of the determination I have when confronted with challenges and problems. I will bring that same vigor, drive, and focus to the Brevard School Board.

As well, I am well-known around District 2 having lived and worked here all of my adult life. I am proud of my reputation as a man of faith, honesty, and integrity.
